# Education that's TN State Specific

- HITA provides over 45 hours every 2 years of CEU's. Members need not attend all education to acquire the State's required 32 hours per 24 month cycle.
- HITA CEU's are primarily taught with the State Standards of Practice in mind or with construction practices that we in the State of Tennessee are seeing. (ASHI and NACHI training is U.S. general)
- HITA CEU's are live fed to four different locations across the state or ZOOM based to your own phone or computer (keeping you close to home and saving you hotel money)
